### **Srinagar Centre:**


1. J&K Public Service Commission, Solina Srinagar

### **Note:-**

1. The admit cards issued earlier are cancelled *abinitio* and the candidates shall carry only fresh admit cards to the Examination Venue.
2. The candidates should read carefully all the instructions mentioned on the admit card.
3. Only those candidates should appear in the Examination, who fulfill the eligibility criteria prescribed for the post as mentioned in the Notification. However, permission to appear in the Examination is purely provisional subject to further

verification of their documents at any stage of selection process.

4. The candidature of such candidates shall be rejected at any stage of process of selection, who are found to have misrepresented or concealed the material facts having a bearing on their eligibility.
